With reference to your online application dated 22.06.2010 on the subject cited above, I am directed to convey sanction for extension of provisional affiliation of the school with the Board for its Secondary School Examination and Senior School Certificate Examination for a further period of Five years w.e.f. 01.04.2011 to 31.03.2016 subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary and senior secondary classes :-

1. The School is required to follow syllabi and course as per scheme of studies prescribed by the Board for the respective Examination.
2. The School is required to abide itself by the Examination/ Affiliation-Bye-Laws of the Board.
3. The School is required to apply on online for further extension of affiliation alongwith the requisite fee and other documents by 30th June of the preceding year in which the Provisional Affiliation expires. Applications will be accepted after the last date along with the prescribed fee and late fee Rs. 10,000/- per month.(Amended Rule 15.11)
4. Provisional Affiliation granted to a school will remain valid on receipt of online application of a school for further extension of provisional affiliation subject to the final decision of the Board.(Amended Rule 15.11)
5. The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the optimum number as under from Pre-Primary to Class XII :-



2. Adequate and qualified staff should be appointed within 90 days on the receipt of the letter of the recognition.
3. That the actual school shall strictly abide by the provisions of DSEAR 1973 framed there under as well as the instructions issued from time to time by the Department.
4. That the school shall admit students without any discrimination of caste and creed.
5. That a proper library shall be established and facilities for the reading room shall also be made available to the students as well as the teachers books in the ratio of 10 books per student shall be purchased and made available to the students.
6. That the adequate sports material shall be purchased and made available to the students.
7. That the employees of the school will be given pay and allowances and other prescribed benefit as provided for under section 10(1) of the DSEAR 1973 and Rule 125 of DSER 1973.
8. That the school shall not run any unrecognised classes or conduct any other activities within the school premises as per Rule 50 of DSER 1973 and all the recognised classes shall be run in one place.
9. That the school shall dispense with the services of unqualified and over aged staff, if any, immediately and the required staff strength must be complete in all respects as per norms.
10. That the school shall submit the returns to the Act branch of the Dte. of Education as per Rule 180(1) of DSER 1973 annually.
11. The Managing Committee shall regulate the functioning of school strictly in accordance with the provisions of DSEAR 1973.
12. The Managing Committee of the school shall not increase fee in the future academic sessions without the prior intimation of the Director of Education which is a mandatory requirement under sub-section 17(3) of DSER 1973.

13. That all the facilities prescribed under rule 50 & 51 of DSER 1973 shall be made available to the students.
14. Proof to the effect that qualified staff has been appointed as per RRs to be provided for verification by the E.O.
15. That the staff shall be paid all arrears and shall be paid as per the Fifth Pay Commission Pay scales, proof shall be given to the E.O. for verification.
16. That the arrangements for good drinking water shall be made for all the students as well as the staff and sanitary facilities shall also be provided to the students and the staff adequately.
17. The school shall have the medium of instructions as per Rule 6, 7 and 8 of DSER 1973.
18. Provident Fund Register shall be maintained and the cash Book completed and shown to the E.O. of the Zone concerned for verification from time to time.
19. That the management of the school shall create a reserve fund of Rs. 2,70,000.00-
20. That the violation of any instructions/conditions/rules and regulations of the Department shall lead to action against the school as per section 21 of DSEA 1973.


